On or about April 15, 2022, CHPE LLC and its wholly-owned subsidiary, CHPE Properties, Inc. (collectively referred to as “CHPE”) intend to submit the first Environmental Management & Construction Plan (“EM&CP”) for Segment 1 of the proposed Champlain Hudson Power Express (“CHPE”) Project. Segment 1 consists of a 17.8-mile overland cable route running from the western shore of Lake Champlain in the Town of Putnam to the Canadian Pacific Railroad right-of-way in the Village of Whitehall. This underground transmission line segment runs through the Towns of Putnam, Dresden and Whitehall, as well as the Village of Whitehall.

On April 18, 2013, the NYS Public Service Commission (Commission) issued to CHPE a certificate of environmental compatibility and public need (Certificate), pursuant to Article VII of the Public Service Law (PSL), to construct and operate the CHPE Project. The Certificate requires that, prior to construction of any portion of the Project, CHPE submit an EM&CP for review and comment.

In general, construction activities for this Segment are anticipated to commence in the summer of 2022. The EM&CP provides detailed information regarding how Segment 1 of the Project will be constructed. The document describes and depicts the specific location of Segment 1 of the proposed permanent right-of-way (“Project ROW”), Construction Zone, and temporary work areas, as well as descriptions of work to be performed, plan and profile drawings depicting the Project, and protocols to be used during construction to protect the community and the environment, and to comply with the CHPE Certificate. The EM&CP must be reviewed and approved by the PSC before construction on this Segment can begin.

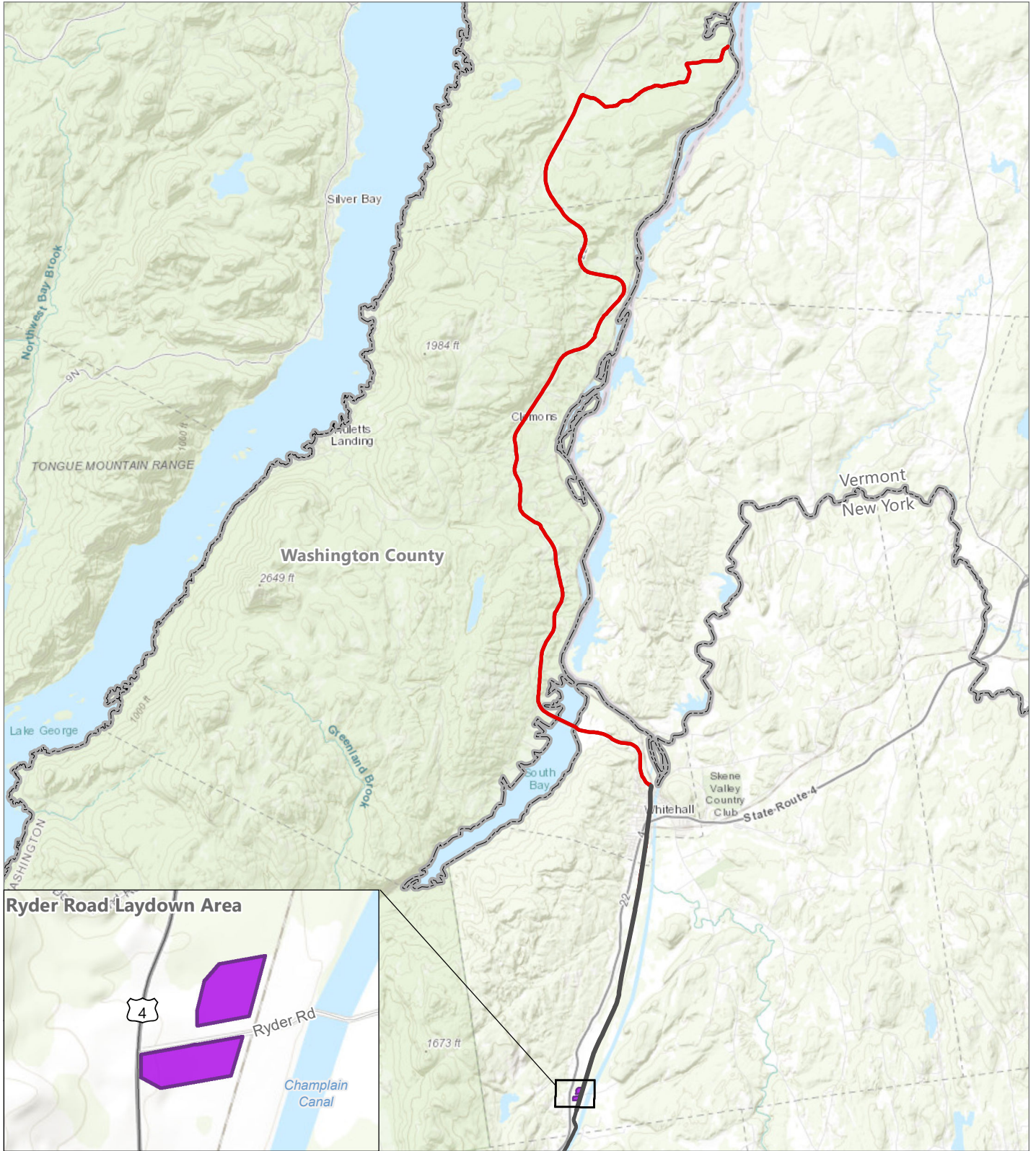

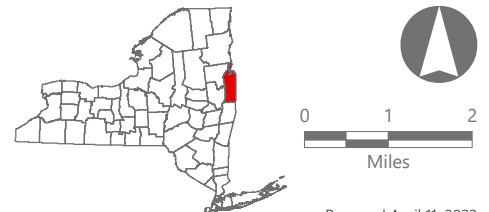
# Segment 1 (Package 1A and 1B) Regional Project Location Including Laydown Area

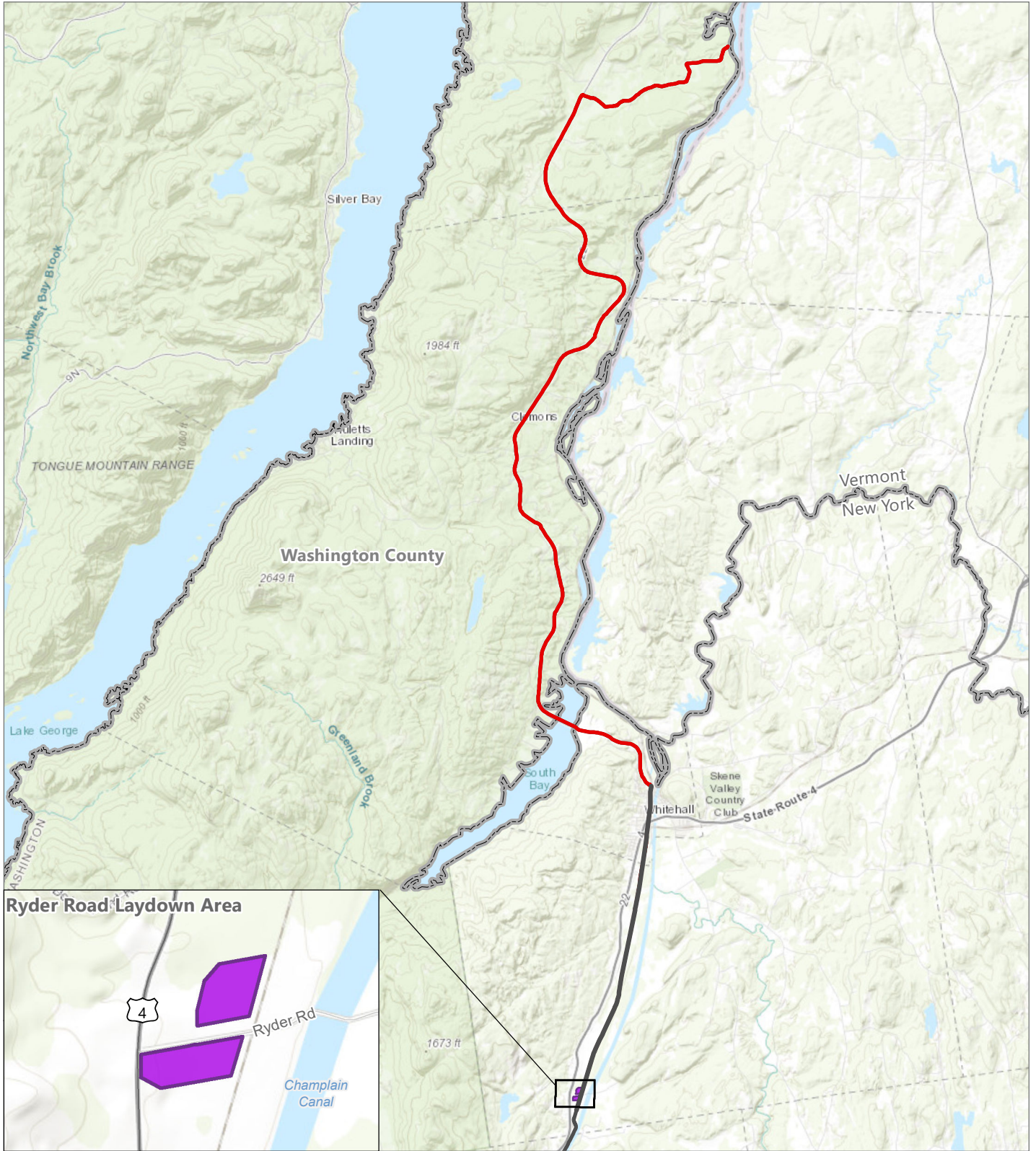

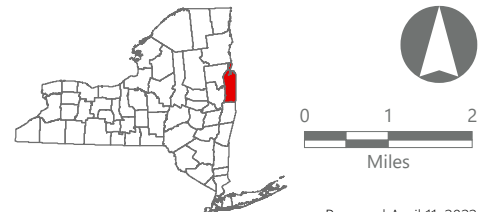
# Segment 1 (Package 1A and 1B) Regional Project Location Including Laydown Area
