## Figure 11. DEC Threatened and Endangered Species - Segment 10 (Package 6)





Figure 13. DEC Threatened and Endangered Species - Segment 12 (Package 7B)





## Figure 14. DEC Threatened and Endangered Species - Segments 13-15 (Package 8)


