## **NOTICE OF SUBMISSION OF ENVIRONMENTAL MANAGEMENT AND CONSTRUCTION PLAN FOR CHAMPLAIN HUDSON POWER EXPRESS**

Please take notice that, on August 4, 2023, CHPE LLC and CHPE Properties, Inc. (collectively referred to as “CHPE”) intend to submit Environmental Management & Construction Plans (“EM&CPs”) for the Segments 6 and 7 of the proposed Champlain Hudson Power Express (“CHPE”) Project. This EM&CP includes installation of approximately 19.8 miles of buried overland cable running from the Town of Milton (Saratoga County) through the Town of Rotterdam (Schenectady County), primarily along railroad and highway rights-of-way.

On April 18, 2013, the NYS Public Service Commission (Commission) issued to CHPE a certificate of environmental compatibility and public need (Certificate), pursuant to Article VII of the Public Service Law (PSL), to construct and operate the CHPE Project. The Certificate requires that, prior to construction of any portion of the Project, CHPE submit an EM&CP for review and comment.

Details of the planned work locations, including an overview map of the proposed route, is available on the Project website at: <https://chpexpress.com/overview-of-public-documents/environmental-management-construction-plan/>. In general, construction activities for these Segments are anticipated to commence in the fall of 2023. Where possible, construction will generally occur during daylight hours, though some limited activities would extend to later hours as needed.

The EM&CP provides detailed information regarding how these Segments of the Project will be constructed, the specific locations of the proposed permanent right-of-way, Construction Zones, and temporary work areas, as well as descriptions of work to be performed, plan and profile drawings depicting the Project, and protocols to be used during construction to protect the community and the environment, and to comply with the CHPE Certificate. The EM&CP must be reviewed and approved by the PSC before construction on these Segments can begin.

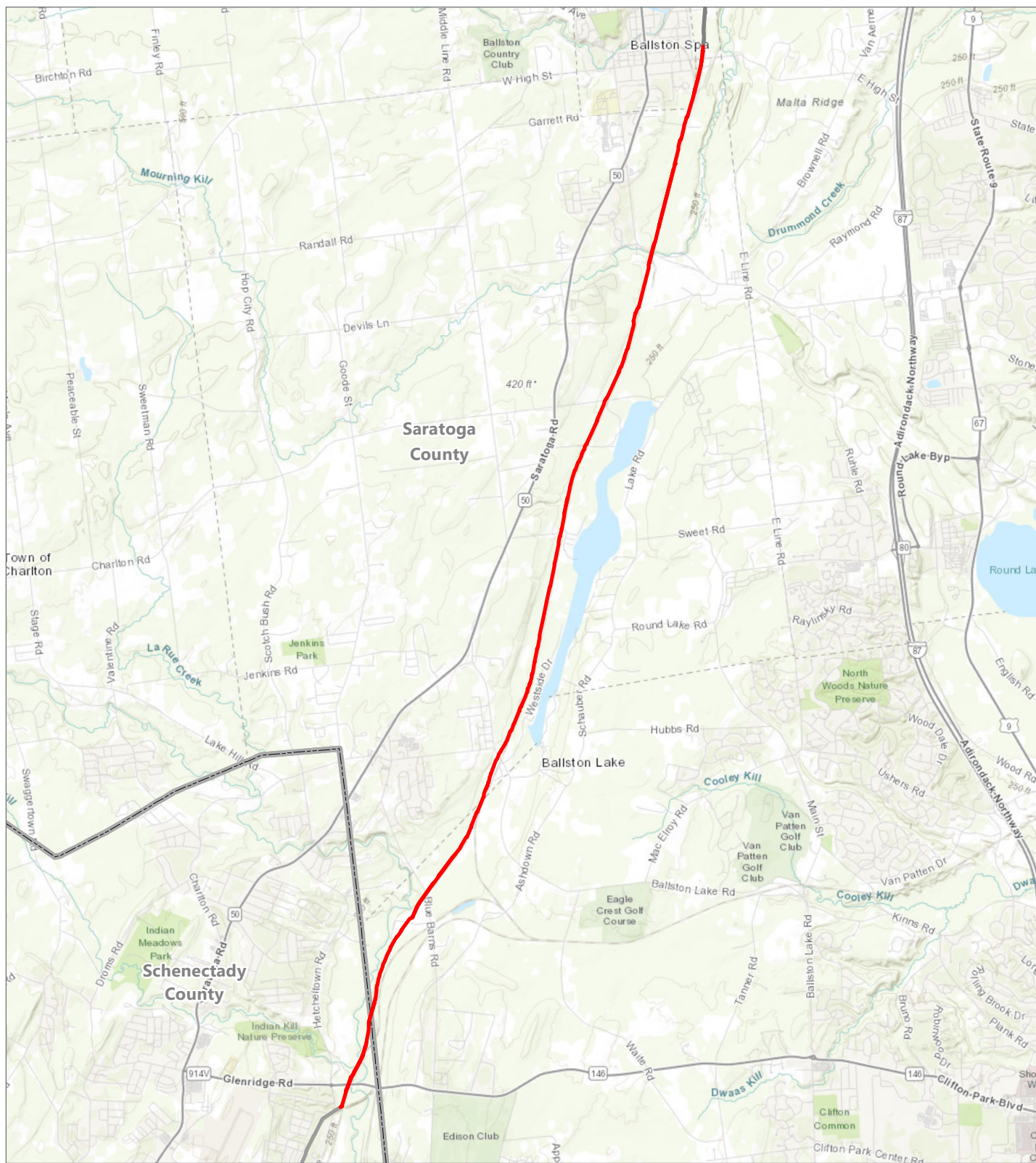

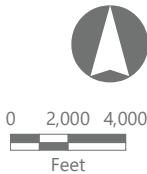
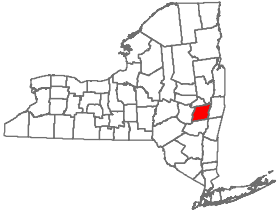
Figure 1. Segment 6 Regional Project Location

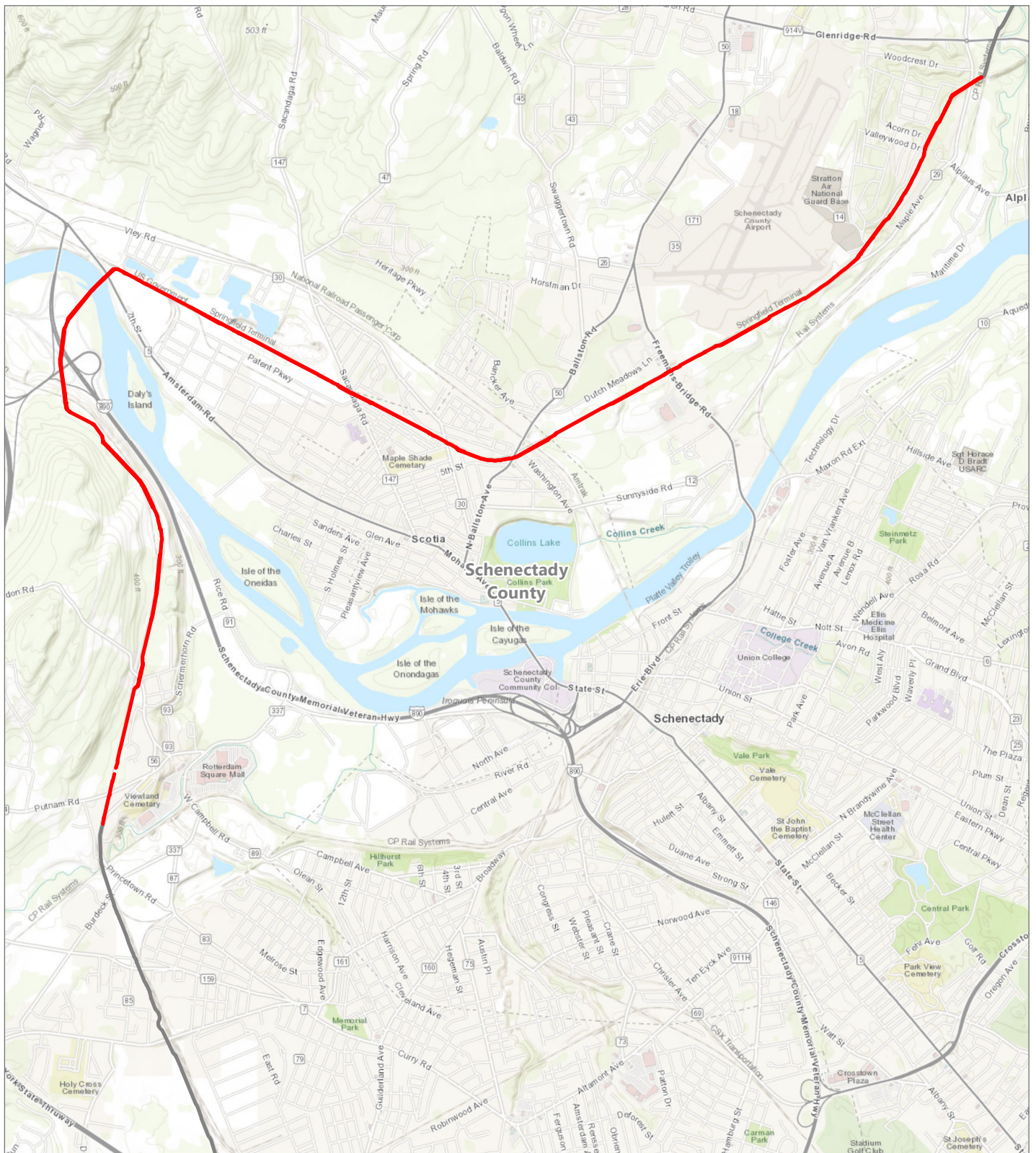

- Project Alignment





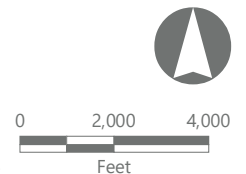
**Figure 1. Segment 7 Regional Project Location**

## **Notice of Submission of Segment 6 and 7 EM&CP For the Champlain Hudson Power Express Project**

On August 4, 2023, CHPE LLC and CHPE Properties, Inc. (collectively referred to as “CHPE”) intend to submit Environmental Management & Construction Plans (“EM&CPs”) for the Segments 6 and 7 of the proposed Champlain Hudson Power Express (“CHPE”) Project. This EM&CP includes installation of approximately 19.8 miles of buried overland cable running from the Town of Milton (Saratoga County) through the Town of Rotterdam (Schenectady County), primarily along railroad and highway rights-of-way.

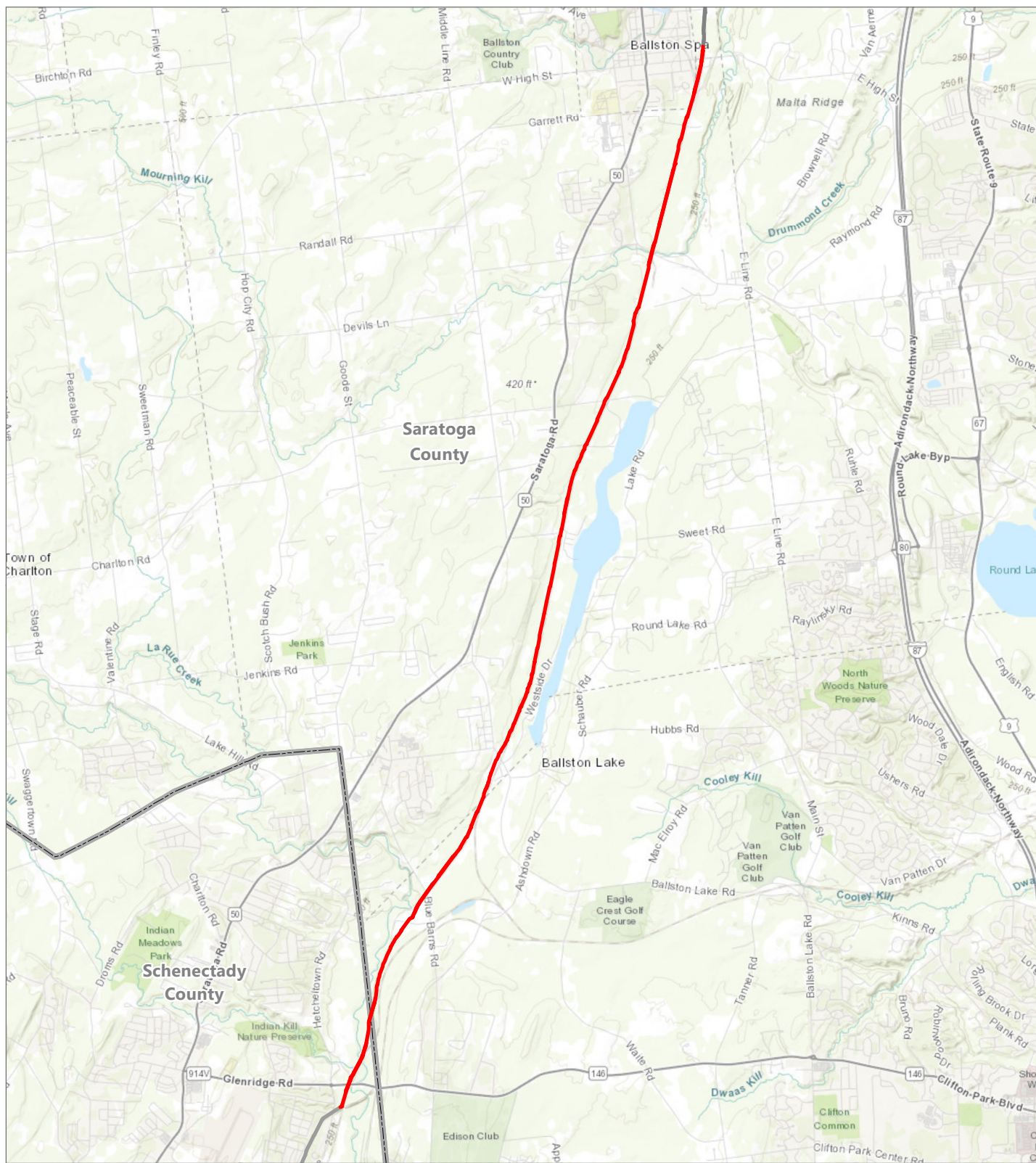

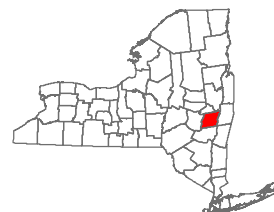
Figure 1. Segment 6 Regional Project Location

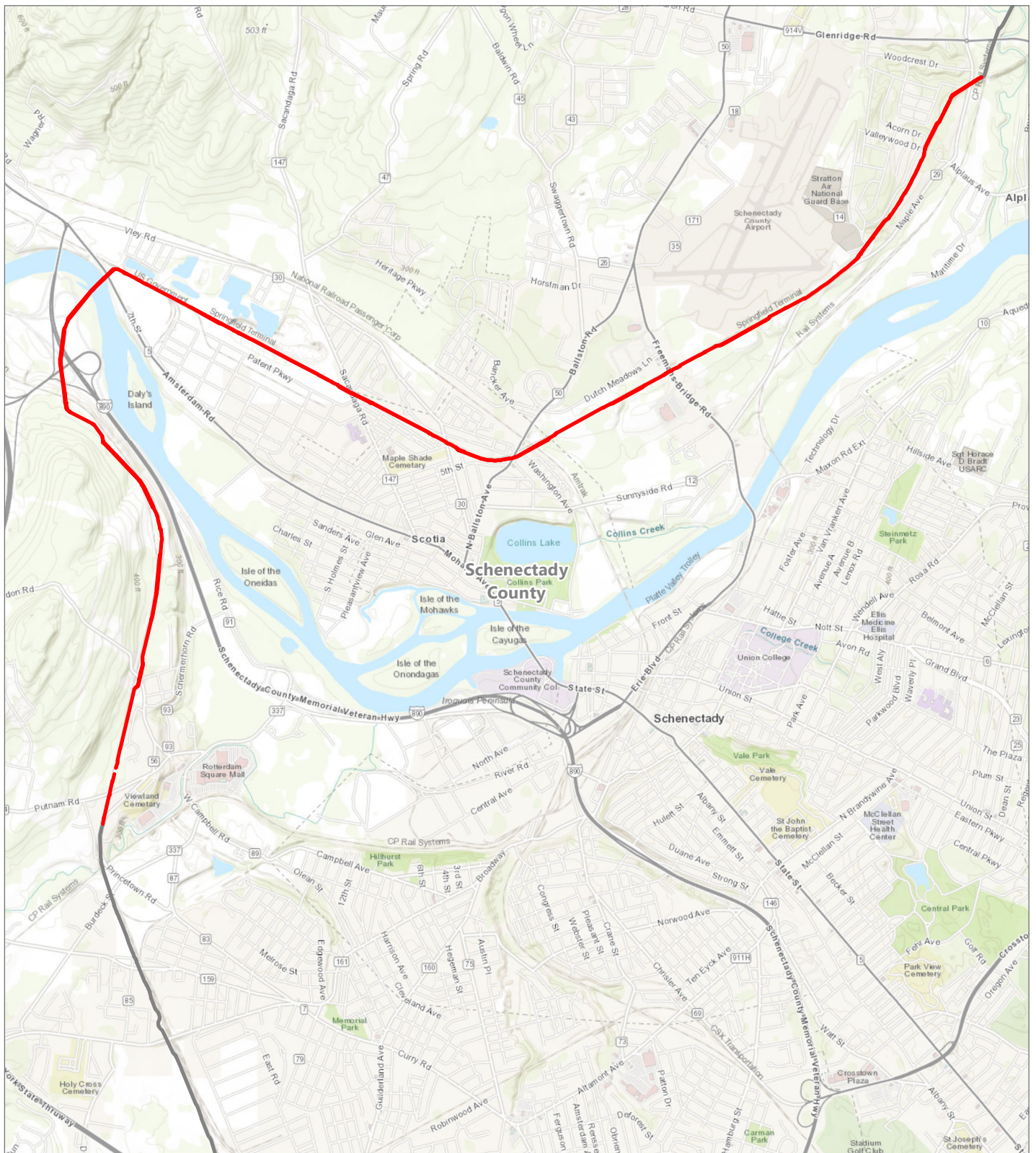

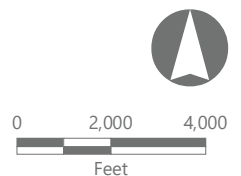
# Figure 1. Segment 7 Regional Project Location

On August 4, 2023, CHPE LLC and CHPE Properties, Inc. We are offering the opportunity to have pre-construction and post-construction inspections performed, including preparation of a report, to confirm that no adverse impacts to your foundation have been caused by these activities. 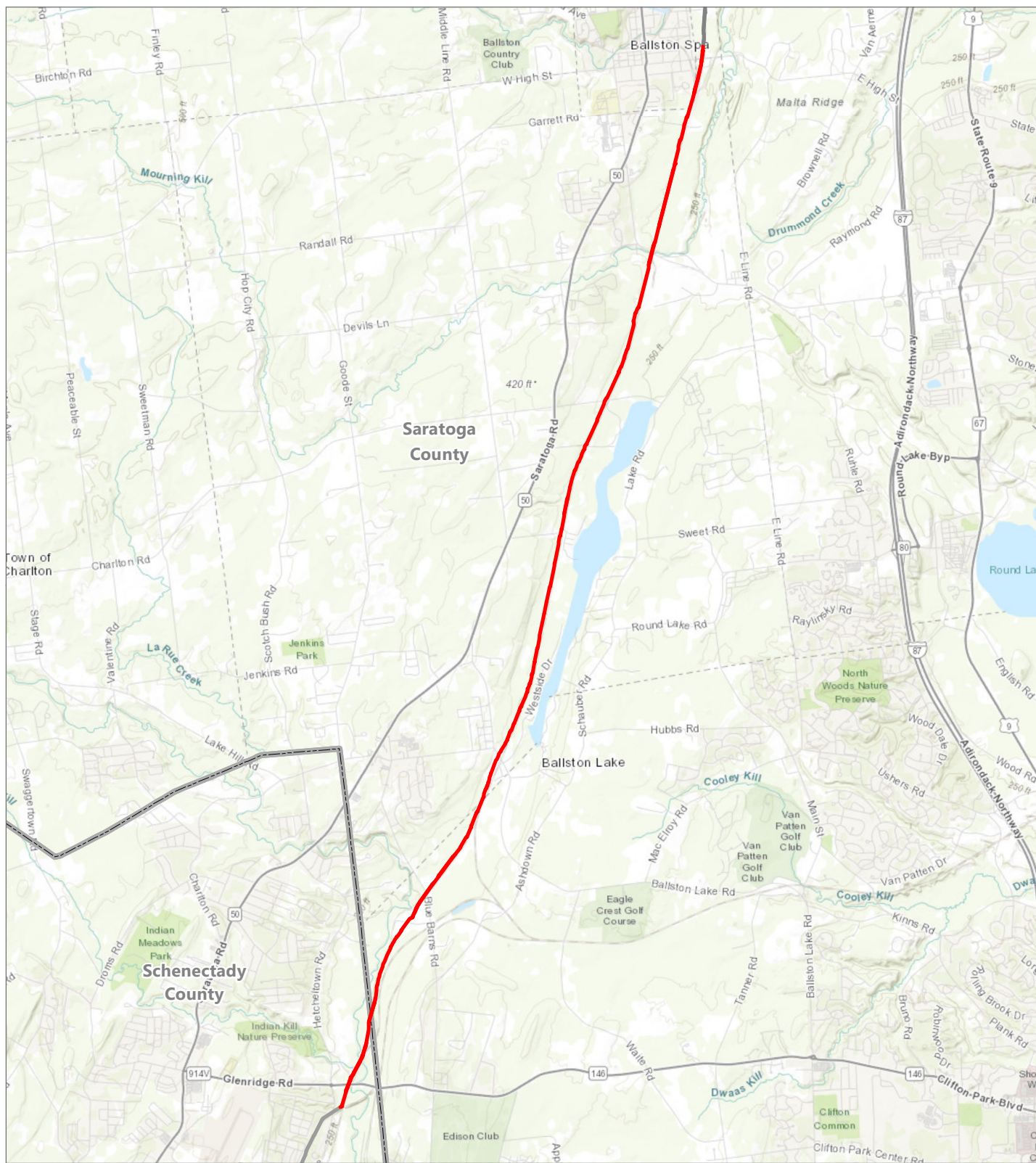

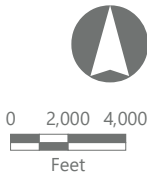
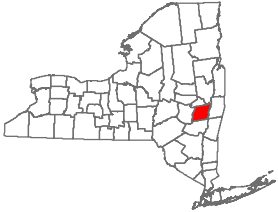
Figure 1. Segment 6 Regional Project Location

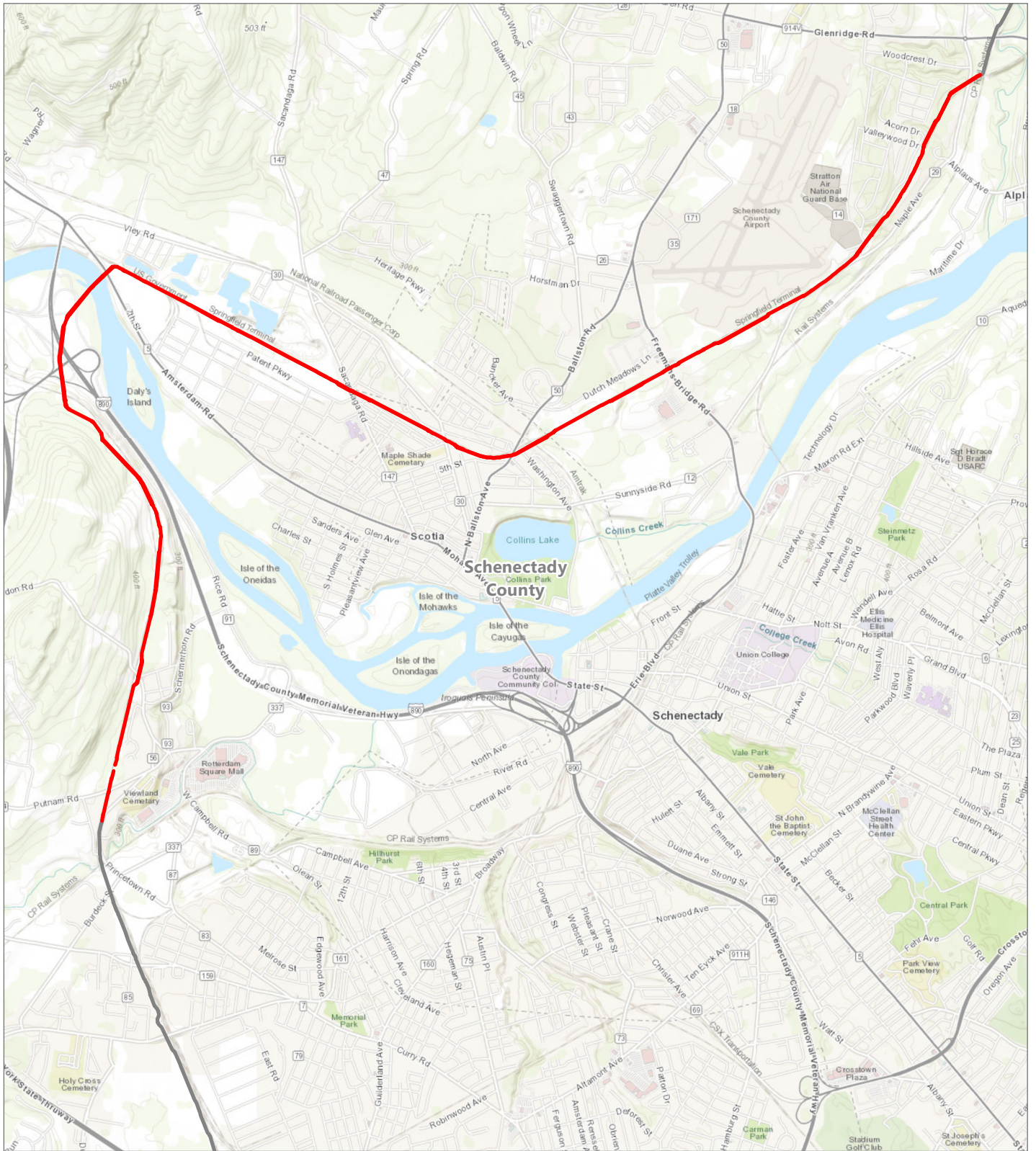
