# Landmark Project - Champlain Hudson Power Express:

In response to New York State's ambitious transition from fossil fuel to clean energy, TDI designed and developed the Champlain Hudson Power Express ("CHPE"), which will will play a key role in New York State's energy transformation, lowering greenhouse gas emissions, creating jobs, and generating billions of dollars in new investment in New York's economy. CHPE is an approximately 339-mile transmission line that will deliver 1,250 MW (enough to power over 1 million homes) of renewable hydropower from the U.S.-Canadian border directly to New York City. The HVDC buried line will travel underwater through Lake Champlain, the Hudson and Harlem Rivers, and underground primarily within railroad and road rights-of-way until it reaches Astoria, Queens, where clean energy will ultimately be distributed onto the New York City power grid. - Engage with Contractor's Craft to promote and support safe work practices, and ensure they are cognizant of the associated risks.
- Collaborate with site personnel to resolve safety issues, escalating unresolved concerns.

#### **Construction Execution:**

- Provide vigilant oversight of construction operations, ensuring adherence to schedule, budget, contract terms, and design specifications through a comprehensive understanding of project documents and regular on-site presence.
- Identify cost and schedule changes, deviations, and risks, bringing them to the attention of leadership and including them in the Critical Items Action List, weekly, and monthly reports.
- Monitor construction activities to ensure Contractor compliance with all project quality requirements, actively communicating technical issues and recommending solutions as needed.
- Identify and resolve blockers promptly.
- Ensure the development of as-built documentation as the project progresses, coordinating with the Contractor to facilitate a seamless close-out.
- Collaborate and coordinate with third parties.
- Attend and actively participate in Contractor's progress meetings.
- Assist in preparing project studies, reports, and forecasts when required.
- Prepare project weekly and monthly reports as necessary.
