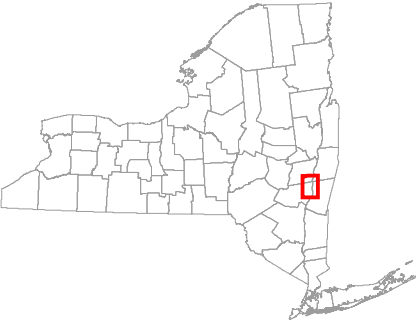

Figure 12. DEC Threatened and Endangered Species - Segment 11 (Package 7A)



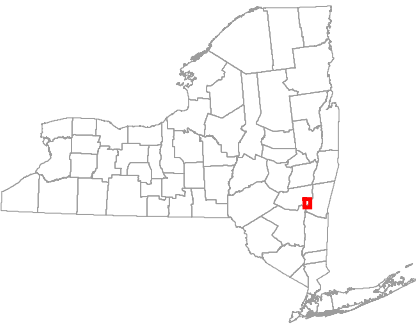

Figure 13. DEC Threatened and Endangered Species - Segment 12 (Package 7B)

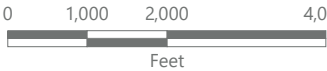
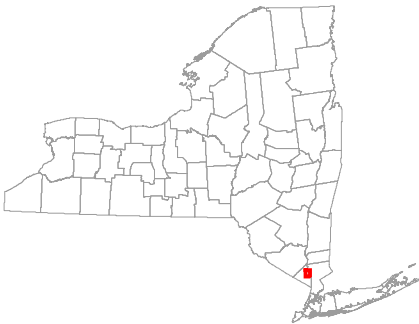

Figure 14. DEC Threatened and Endangered Species - Segments 13-15 (Package 8)



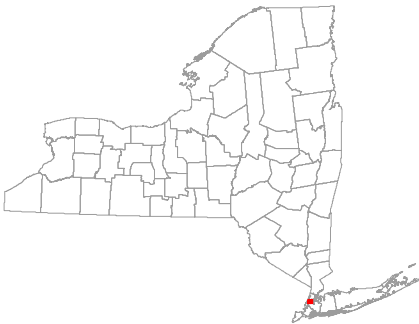

The MBTA has no provision for allowing take of migratory birds that may be unintentionally killed or injured by otherwise lawful activities. 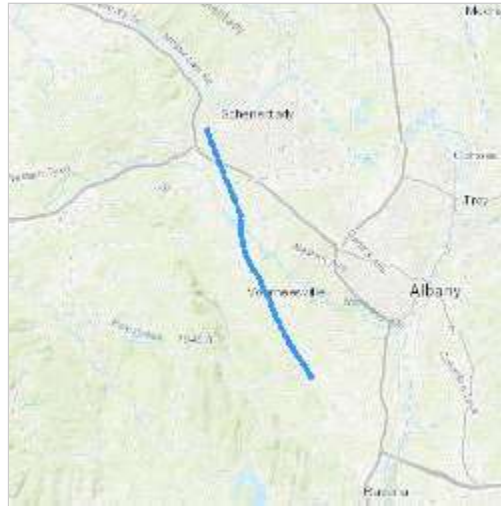
